

**HUD FORMS TYPICALLY UTILIZED BY HOUSING AGENCIES FOR COMPETITION
SOLICITATIONS (i.e., QSPs; IFB's; RFP's RFQ's) [Version 2-13-2021]**

Within the following table is listed a number of forms, most HUD-mandated, that housing agencies typically utilize for competitive solicitations that the agency may issue. I am providing this listing uncompensated as a public service. This listing is NOT guaranteed to be "all inclusive" of all forms that may be required for any and all solicitations, it is only a representative listing of some of the forms that I have utilized in conducting competitive solicitations for a variety of housing agencies.

As a reminder, I distribute at no-charge to housing agencies sample competition templates for a variety of services and issues that housing agencies typically issue competitive solicitations for, including templates for construction, maintenance, and a variety of professional services.
